The Young American Medal for Service is awarded to those United States citizens who, during a given calendar year, have achieved outstanding or unusual recognition for character and service. Character demonstrated and service accomplished must have been worthy of public report, and must not have been undertaken for the specific purpose of receiving any form of recognition. No more than two such medals may be awarded each year. The individual must have been 18 years of age or younger at the time his or her service received public recognition.

For a candidate to be eligible to receive the Young American Medal for Service, the completed nomination file must be sent to the Young American Medals Committee, U.S. Department of Justice, Office of Justice Programs, 810 7th Street, NW, Room 6246, Washington, D C. 20531. Nominations must be signed by the governor of the state in which the service took place.

To be considered, the nomination file must include:

- A copy of this completed form,
- A certified birth certificate or other evidence of the date and place of birth of the nominee,
- Two or more statements by witnesses or individuals having personal knowledge of the facts surrounding the candidate's noteworthy service,
- A biographical sketch of the candidate, and
- A detailed account of any public recognition the candidate has received for his or her endeavor. This includes recognition of awards from any state, local, religious, or other organizations as well as any press coverage of the event in which the candidate displayed exceptional service.
